Sl. No.	The school is directed to ensure that:
1	The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to X shall be restricted to 10. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The school has converted regular cubicles into CWSN toilets, but they are very narrow and there is no room for a wheelchair/walker to navigate. 3	The school does not have partition in boy's urinals. Thus, the school is required to construct the partition in the boy's urinals within 03 months and submit the compliance.
4	The composite science lab is appearing to be slightly under stocked and it does not have gas connection. Thus, the school is required to procure more equipment / apparatus / salt and maintain the gas connection in the workstations within 03 months and submit the compliance.
5	The mathematics lab is appearing to be used as SST lab, as a map is seen in the same. Thus, the school is directed not to use the mathematics lab for other activities and submit an undertaking in this regard on its letter head within 03 months and submit the compliance.

- 5. The school shall renew mandatory certificates from time to time.
- 6.
